A complete set of bidding documents in English may be purchased on or before 30th days from the first date of publication, in case of sealed quotation it should be on or before 15th days from the first date of publication, from the Office of Mahabharat Rural Municipality, Banakhuchaur, Kavrepalanchowk. The e- bidders must submit the receipt or bank voucher, of Rastriya Banijya Bank deposit account no 1040303007106 for purchasing of bid document, otherewise the bid shouldn't be valid.

- 4. Sealed Bids or sealed Quotation or e-bids, must be submitted to *Office of Mahabharat* Rural *Municipality, Banakhuchaur, Kavre on* or before 12:00 hour's noon on **31 days from first** *publication date.* In **case of sealed quotation**, the quotation must be submitted to **16th days from first publication date**.
- 5. Sealed Bids or e-bids shall be **valid for a period of 90 days** after the deadline of bid submission but in case of sealed quotation, it shall be valid **for a period of 45 days.** All sealed bids or quotation must be accompanied by a bid security of amount and bid security period as mentioned above, Bids will be evaluated on the basis of the package.
- 6. Bank Guarantee issued by any finance company in any form will not be accepted.
- 7. Sealed Bids or sealed quotation or e-bids received after the deadline of the submission will be rejected. Bids received by the above mentioned deadline shall be opened physically in the presence of the Bidders representatives who choose to attend at the address above at 13:00 Hours on 31 days from the first date of publication. In case of sealed quotation, it should be open 16 days from the first date of publication.
- 8. If the last day for purchasing and submission falls on a government holiday then the next working day shall be considered as the last day.
- **9.** Sealed bids or quotation should comply in all respects with the Instruction to Bidder included in the Bid Document. Non compliance with this instruction shall result in disqualification.
- 10. The purchaser reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
